



Activities for the year 2018-2019:


1. A talk on "Leadership and Motivation in Social Work Management" On 30th August 2018

She is the winner of the GoUNESCO Challenge where she visited all the 28 UNESCO sites in India and is the Co-Founder of the Hyderabad Chapter of the Bikerni. She has raised funds and organised Hyderabad city tour for 40 orphan girls schools and currently offers aid to 4 NGOs in Hyderabad. Among her many achievements is the Road to Mekong expedition to ASEAN nations, covering 17000 kms in 7 weeks to promote Incredible India.



In her slide show, she told us about 10 essential values in order to achieve your goals in life and become successful. She encouraged us to work hard to achieve our dreams. She described the various obstacles she tackled in her journey and gave us life changing lessons on importance of discipline and dedication to your dreams. "If there is a possibility, never look back and just go grab the chance"- she said while telling us how she managed to accomplish her dream.

According to Jai Bharati, it is important to have a passion and perseverance. One should be determined and dedicated towards their goal and always carry a disciplined attitude. Courage and commitment were required as strong foundations as she herself is a motivational speaker who has encouraged her audience to work hard and support their peers along their journey. She narrated several stories of her experiences during biking trips and we felt inspired and awestruck by every one of them.





3. Organized Dignity March' reaches Hyderabad on 5th Jan, 2019



The 'Dignity March', aimed at ending sexual violence against women and children, reached Hyderabad at St. Ann's College for Women on Saturday after covering Maharashtra, Karnataka, Kerala and Goa. Survivors of rape and sexual violence and families from various States participated in the march. The march, initiated by the Rashtriya Garima Abhiyan along with several like-minded organisations, is a 65-day national event that will see survivors and other stakeholders travel 10,000 kilometres in 200 districts of 24 States and union territories in India. 


6. Chiguru event on 16th Dec


10. Knowledge café



INAUGURAL FUNCTION


The two-day training program commenced with an inaugural function wherein **Ms. Popy Devi Nath**, Director, Center for Women Studies, welcomed the gathering. The briefing of the training was delivered by **Br. Albert Xaviour**, Director, BIRDS, Bangalore.

Rev. Sr. Dr. P Amrutha, Principal, St. Ann's College, Hyderabad, Inaugurated the training program. She reminded the students about the significance and worth of organizing such trainings with regard to the present scenario of the country.



TRAINING SESSIONS

The training sessions were conducted by **Br. Albert Xaviour**, Director, BIRDS, Bangalore. The first session was inclusive of self-introduction of the participants and their expectations from the program, formation of groups, followed by the history of IARF, HRRC and BIRDS. In the following session, a short video on the history of Human Rights was played which was followed by the explanation of the different kinds of Human Rights and the need for Human Rights Education. The explanation of the different rights was enhanced through various activities based on Human Rights.





Further, presentation and group discussion on the UDHR articles was also held and all of the five groups had presented the articles allotted to them in a creative way. The participants were also assigned to present each article through a skits and role play.




DAY 2:

The second day's session started with the introduction and a brief discussion of POCSO Act, Conflict Resolution & Peace Building. This was followed by skit performances related to the UDHR articles where all the students took an active part.


VALEDICTORY FUNCTION




Inauguration and Lightening of Lamp


TECHNICAL SESSION

Dr. Sudeshna Mukherjee, Director of Centre for Women's Studies, Bangalore University has talked on the Positive and Negative Impact of Social Media on Women. Information technology helps in the liberation of women and their empowerment too. As an empowering tool, it promotes better interaction, sharing of information and acquisition of skills that are essential for every girl. Dr. Sudeshna Mukherjee delineated on popular perception and legal perception. The leading movements such as Hash Movement, Nirbhaya Movements and awareness on menstruation had witnessed a fair share of participation by women. The need to introduce gender identity as a curriculum in the schools was recommended.

trafficking and even use of blogs, logos of famous firms and banks to misguide the general public, international ramifications on cyber-crimes and misuse of technology has been highlighted.



PANEL DISCUSSION

Panellists were: Prof. Hiranmayee Mishra, Dr. Sudeshna Mukharjee, Shri M. A Shakeel, and Smt. Shubhi Dwivedi.

Prof. Hiranmayee Mishra, CWS, Udayanath Autonomous College of Science and Technology, Cuttack made an opening remark on the transformation of the world where every user has to share information about UID, personal profiles, chatting with unknown people, information related to personal security such as passports information, and the use of smart phone, victimization of crime and dealing with the crimes. The role of the family, community, NGO's and peers in helping the victim plays a great role. The need to sensitize children is crucial. Before, some may end up as hawkers and stalkers whiles others are victimized. Lacunae in the existing Information Act – Cyber-crimes are not treated separately. A word of caution was made not to make personal, political or public.







Mr. M. A. Shakeel, Lawyer described on the provisions related to technology as a boon or bane and the need to use it wisely. He further explained on legality of the crime, punishment, defining the terms and elaboration on various Sections. For example: Section 66 A, Section 66C, Section 66 D, Section 66 F, andSection 67 A. Punishments, penalty, trappings, obscene material, sexual explicitly, offence, perpetrator, violation, evidence of crime role of cyber cell are highlighted. Identification of various crimes, variation in the punishment, and penalty amount etc. were discussed.

Ms. Shubhi Dwivedi, Director, Programs, Rubaroo was the moderator for panel discussion. Moderator posed a query to the participants regarding the legal basis for the use making accounts in facebook, instagram, and the use of various apps.

Dr. Sudeshna Mukarjee described the position of women in the cage, which was inspired by Dr. Ruqquia Hussain, an educationist and novelist. Silence of good, cyber-security and its discrepancy were focused. The need to regulate the rules and regulations of cyber-technology, informed choices consciously, role of peers, malicious message, and judicious use of social media, and making use of technology for development were also included.

A short film screening made by students of St. Francis College for Women delivered a message on the role of cyber-crimes among the youth.

VALEDICTORY SESSION

Valedictory speech was delivered by Prof. Hiranmayee Mishra, where she stressed on the nuances of cyber-crimes and making the child aware about the trappings. Winning of trust of adolescent girls getting bullied, hacking can be prevented by equipping them in self-defence training program, personality building, offline register of crimes, E-FIR were suggested.

Prof. Hiranmayee Mishra gave away prizes and certificates to the winners of Poster Presentation & Short Film contest.

Ms. Popy Nath Devi, Director of Centre for Women's Studies presented vote of thanks. She thanked the delegates for making the conference a huge successes and enlightening the participants on the use of cyber space more safely and with security.

3rd Year Students (Bsc, BBM, Bcom, B.A)


AECC covered around 1000 students in a year

Objectives of the Course:

- To develop students' sensibility with regard to issues of gender in contemporary India.
- To provide a critical perspective on the socialization of men and women.
- To introduce students to information about some key biological aspects of genders.
- To expose the students to debates on the politics and economics of work.
- To help students reflect critically on gender violence.
- To expose students to more egalitarian interactions between men and women.

Learning Outcomes:

- Students will have developed a better understanding of important issues related to gender in contemporary India.
- Students will be sensitized to basic dimensions of the biological, sociological, psychological and legal aspects of gender. This will be achieved through discussion of materials derived from research, facts, everyday life, literature and film.



Objective of the course: The objective of this course is to understand the concept of fender and present a bird's eye view of what living in a gendered society means for the women. It would recognize gender as central to the analysis of structures of power both with in and outside the family and in the world around us. The course is structured around the premise that gender is socially constructed. It will offer opportunities for an interdisciplinary exploration of various dimensions of this premise. While a cross cultural perspective is kept in mind, the course would focus on the Indian experience.






