

REPORT

The following grievances have been received in the current academic year:

- Students requested for addition of new food item in the canteen.
- Students requested for Half day timing of the college in the month of Ramadan i.e, May as muslims observe fast throughout the month and also an extreme heat wave forecast was issued in Hyderabad.
- Students requested for postponement of CIA-2 exams due to heavy rainfall in the city and waterlogging in some areas.
- Students raised a concern regarding the sanitary practices of the cooks during the preparation of meals which can lead to contamination of the food and also about the general hygiene and cleanliness of the college canteen.

- Students who travel through public transportation requested to grant them permission for entry in the college premises even after 9:00 am.
- A concern was raised by a Sports student stating that she would like to attempt all her CIA exams and could score better marks than the assignment marks, balancing both her academics and sports

The above grievances listed above were forwarded to the person concerned and the following actions were taken:

- Management granted permission for the same. Hence, a new food item i.e, Momos was added to the canteen's menu.
- Keeping the students request and wellbeing in mind, the committee decided to grant half day college timings in the month of Ramadan/May.
- The committee after much discussion decided not to postpone the exams as the chances of rain shown in the weather forecast on the exam days were negligible
- The cleanliness concern was taken to the canteen committee head and necessary action for the same was taken.
- The student's request was approved by the management stating that students with genuine reasons would be allowed with prior permission by Sr. Principal.
- The Controller of examination gave their approval for the conduct of CIA examinations for the concerned sports student after discussing with Sr. Principal.
